Ambitious And Confident Children & Young People

Early Years Services

A child's "Early Years" are defined as from pregnancy to 8 years, recognising the importance of pregnancy, pre-school years, and transition into primary school for a child's education and life prospects. During pregnancy and very early years the following have a significant impact on a child's health and early development: use of alcohol, tobacco and drugs during pregnancy; parenting skills; unintended teenage pregnancies; healthy nutrition during pregnancy; breastfeeding; and maternal mental health following birth.

During a child's early years and transition into primary school, key services include nursery provision and Additional Support Needs (ASN). Available information suggests that around 91% of eligible children in Moray take up their nursery entitlement. There has been an increase over recent years in the number and proportion of children in Moray with ASN. Also, the proportion of children with ASN in Moray who have more complex needs is above the national average, although this has fallen over recent years.

Moray Schools: Attainment and Wider Achievement

While a child's early years is the time when a solid foundation for skills can be laid, their school years provide an opportunity to encourage the importance of skills and the world of work. School education should equip young people with high levels of literacy, numeracy and ICT (measured through the exam system), but also give pupils the opportunity to build a strong foundation of wider achievement by developing a variety of skills.

The new Curriculum for Excellence in Scotland will allow pupils to access opportunities to build work-related knowledge, experience and skills that would be useful throughout their life. This recognises that vocational learning is a valuable alternative to academic learning.

Climate projections for north and east Scotland suggest an increase in winter precipitation (rain, sleet, hail and snow), and decrease in summer precipitation.
